TRE Ballot Tax Rate Explanation

The \$1.33228 tax rate listed on the ballot is in place as a failsafe or protection against a majority vote “against” the TRE. By raising the rate by the same 13 pennies that we ultimately want to “move” to the M&O fund, if a majority of voters say “no” to the TRE, we will still have the pennies in I&S fund that we need to pay our debts. If we did not structure it this way and the TRE did not pass, we would end up with an M&O rate of \$1.04 and an I&S rate of \$0.03228 and not have enough total pennies to pay our debt without going into our fund balance or District “savings” account.

In good faith to the community, the board has already passed the ordinance stating that if the TRE is approved, the I&S rate will be reduced by 13¢ keeping the overall rate at \$1.20228 (M&O \$1.17 and I&S \$0.03228) and the District will get the \$500,000 for our students.
